Pacific Islands Trade with China 2021

Pacific Trade Invest China is pleased to present the China-Pacific Islands Trade Statistics 2021. The handbook is a compilation of statistics that provides the value of trade in goods across key industries and an analysis of key trends of trade between China and the 16 Pacific Island countries.

The year 2021 marked a positive growth in international trade across the globe following the unprecedented threat to key global supply chains across key markets and production capacity for global business as a result of COVID-19. Pacific Island businesses are gradually recovering from this impact with a steady pace throughout the year. Unlike the growth in China's trade notably faster than that of other economies in the world.

In 2021, China's total imports and exports hit a historical height of \$US6.05 trillion, exceeding \$US6 trillion for the first time showing the resilience of China's growing cross-border trade, which is of great significance to the stabilization and improvement of the Asia-Pacific economy, as well as the recovery of the world economy.

Despite the volume of trade between China and the Forum Island Countries (FICs) relatively low compared to those with China's major trade partners', in 2021, the total value of trade between China and the FICs reached almost \$US9.9 billion, an increase of 10% year on year, comprising of exports from China to the FICs of almost \$US5.5 billion and exports from the FICs to China of almost \$ US4.4 billion. The top five exporting FIC's to China were with Papua New Guinea (PNG), New Caledonia, Solomon Islands, Fiji and Federated States of Micronesia (FSM) and minerals, nickel, timber, iron and ore, slag, ash being the top exporting commodities; while Marshall Islands, PNG, Fiji, Solomon Islands and New Caledonia being FICs' top 5 importing countries and ships, minerals, machinery parts, iron, and electric machineries being top importing commodities. The volume increase demonstrates the encouraging news that in the post-COVID era, exports and investments from China have been warming up and the business interests for Pacific businesses have been rising.

The top three countries with the highest growths are FSM, with an increase of 140% or about \$US17 million, mainly in aquatic products; Fiji, with an increase of 135% or about \$US55 million, mainly in ore, slag, ash and timber products; Vanuatu, with an increase of 51% or about \$US11 million, mainly in aquatic products. The country with the highest growth in net exporting value is PNG, with an increase of 27% or about \$US2.9 billion, mainly in liquefied natural gas, nickel and aquatic products. It is also noteworthy that New Caledonia has made a breakthrough in timber export. From 2017 to 2020, New Caledonia had not exported timber to China for four years, while it has achieved an exporting volume of about \$US3 million in 2021.

In contrast, some countries have lower exporting volumes than previous years'. Amongst them, the iron and steel exports of New Caledonia decreased from \$US1.14 billion to \$US1.06 billion, the aquatic export of Marshall Islands decreased from \$US7.6 million to \$US2.4 million, while the iron and ore exports of Solomon Islands are \$US39 million in 2020 but zero in 2021.

Through the statistics we can also see the most popular FICs exporting commodities of minerals, nickel, timber, iron and ore, slag, ash account for more than 98% of the total exports, which indicates the trade shares of other processed products, including aquatic export, are comparatively small. The indication presents both challenges and opportunities. We believe that if the FICs can leverage own resources and advantages, enhance understanding of the Chinese trade policies and business culture, and prepare "China-ready" strategies, businesses and commodities for the Chinese market, we will see even higher trade growth and more diversification in the trade shares.


